Commissioner Page – Information provided. County Commissioners said no to the City on the Police Department. Professional people that work for the County will get Health Insurance right away. On the budget, looking at no raises for non-bargaining unit people. State still making cuts, County trying to pick up slack not sure how long they can continue. Planning/Zoning changes – 4-9 dogs can do a private kennel. Also Pier 33 project and rezone was approved.
