

Oak Hill Cemetery is located in Benton Township just north of Aloha Township, five miles south-east of Cheboygan on M-33 in Cheboygan County. Oak Hill Cemetery, is owned by the Townships of Aloha, Benton, Grant and Mullett. It is operated and managed by a Cemetery Board.

The Board shall use the Oak Hill Cemetery Ordinance to regulate this cemetery. All records for the cemetery are maintained by the Oak Hill Cemetery Clerk.

## *Oak Hill Cemetery*

### **General Information**

- A family can purchase up to a maximum of four burial spaces.
- A cemetery lot can be from one to four burial spaces.
- A resident or taxpayer of Aloha, Benton, Grant or Mullet townships can purchase burial spaces for \$30 apiece. Non-resident fee is \$300 per burial space. Effective 8-1-10 cost will be \$100/\$500.
- Storage fee, for Non-residents only, during winter or frost months, or if no burial in Oak Hill is \$40 per month.
- Cost of grave opening/closing is Adult-\$400, Baby-\$200 and Cremation Urn \$100. Fee to be paid when completed.

Costs are payable to Oak Hill Cemetery Clerk.

### **RULES AND REGULATIONS FOR OAK HILL CEMETERY**

1. NO TREES, SHRUBS OR PLANTS SHALL BE PLANTED IN CEMETERY WITHOUT THE PERMISSION OF THE CEMETERY BOARD.
2. CEMETERY BOARD MAY ORDER ANY TREE, SHRUB OR PLANT REMOVED OR PRUNED WHEN IT DEEMS THE SAME IS NECESSARY.
3. CEMETERY BOARD SHALL HAVE GENERAL SUPERVISION OF THE CEMETERY AND ALL WORK THEREIN.
4. NO FLOWERS SHALL BE PLACED ON GRAVES UNLESS CONTAINED IN A SUITABLE CONTAINER. BEDDING PLANTS MAY BE PLANTED WITHIN 8-10 INCHES IN FRONT OF BASE OF MONUMENT BUT NEVER OVER ENTIRE GRAVE. ALL ARTIFICIAL FLOWERS OR ARTIFICIAL CONTAINERS, INCLUDING WIRE, GLASS, SILK OR PLASTIC, ARE NOT ALLOWED ON CEMETERY GROUNDS. OTHERWISE THEY WILL BE DISCARDED.
5. GRAVE BLANKETS, WREATHS AND OTHER WINTER DECORATIONS WILL BE ALLOWED FROM NOVEMBER 1ST THRU APRIL 15TH.
6. ALL MONUMENTS REQUIRE APPROPRIATE FOUNDATIONS TO BE IN-

STALLED BY CEMETERY AT LOT OWNERS EXPENSE. SEE CLERK FOR DETAILS.

7. ALL NEW GRAVES MUST BE MOWABLE. ALL RENOVATIONS TO EXISTING GRAVES MUST BE MOWABLE.
8. BENCHES MUST BE PORTABLE.
9. AS OF 9-1-10, NO EDGING OR PERIMETERS ARE ALLOWED AROUND GRAVE SITES.
10. GRAVE SITES MUST BE MAINTAINED ANNUALLY.
